**Payment~**

A \$40.00 non-refundable deposit is due in advance to guarantee booking. If the date is secured by the Bride, the deposit will be applied to your final balance. Full payment is due upon delivery of services on the day of Wedding. We accept Visa, MC, AE, Discover, checks made payable to Canvas Hair Salon, LLC and or cash. \*Gratuities are not included in full payment.

**Pricing~**

Rates are per person and are based on reasonable and normal circumstances. Once the contract is signed with current rates, you are guaranteed that price if the rates increase. Weddings that fall on a holiday are subject to increased rates.

## Booked Business~

Canvas Hair Salon, LLC requires a minimum booking of the bride and two attendants for any off-site venue. We require a signed contract and deposit of \$40.00 to hold your date. A signed contract and deposit should be received as soon as possible to ensure that your date is reserved.

## Final Head Count~

A final head count is due 2 weeks prior to the date of the Wedding. You may not decrease your final count after this time. If Canvas Hair Salon, LLC trials the bride, the bride is required to have her hair done by Canvas Hair Salon, LLC along with the number of attendants the day of the scheduled event. The bride is required to notify Canvas Hair Salon, LLC~ 6 weeks in advance if there is a cancellation. If the head count increases, you are required to notify us as soon as possible. If actual count is over on the day of the Wedding, payment for additional services are due upon date.

Cancellation Policy~

Deposits are non-refundable if you should cancel your booking. Please be advised that once your Wedding is booked, all other events for that date and time are turned away. By signing this contract, I have read and understand the terms and conditions outlined above. I will abide by this contract.
